Peggy presented the Executive Director's report for February and March for Fixed Route & Shared Ride. Ridership, revenues and on-time performance were good in February for both Fixed Route and Shared Ride. In March, ridership and revenues came down in both Fixed Route and Shared Ride due to the COVID-19 pandemic.
